**ORDER**

In pursuance of Govt. letter No.DSW(ICDS)G/SNP/134/2021/140 dated 10.01.2022 and letter No. DSWO (G) 324/2021/Pt-V/266/11 dtd 05.02.2022 received from District Social Welfare Officer, Goalpara, the allotment of 4950.30 qtls of fortified Rice under Wheat Based Nutrition Programme (WBNP) under supplementary Nutrition Programme for 4<sup>th</sup> quarter of 2021-22 the GPSS/WCCS wise Sub-allotment of Rice is made to the following in respect of Goalpara district.

The GPSS/WCCS Ltd. of Goalpara will lift Rice under Wheat Based Nutrition Programme from the F.C.I. FSD, Goalpara, Bhalukdubi. The last date of lifting is 28.02.2022 & Scale of issue-120 grams per child per day for 66.57 days.

The Secretary (All) GPSS/WCCS Ltd. they are directed to lift the allotted quantity of fortified Rice from the FCI within the validity and deliver to the FP Shop agents (copy enclosed) as per scale for distribution to the respective Anganwadi Centre after identification by the supervisor & submit transportation bill in duplicate for making payment.
13. Concerned FP Shop agents of Goalpara district. They are directed to receive the allotted fortified Rice from the Secretary of their respective GPSS/WCCS & handover the same to Anganwadi Worker Centre.
