2. Registration under Domestic Violence Act 1995.
3. Certified Copies of Bye & Memorandum of Association with a Provision in its objectives of Work for victims of Women.
4. Valid executive committee Certified by the competent authority.
5. Self Attested copies of last 3 years Audited Statement of Accounts.
6. Signed Copies of last 3 years Annual Report.
7. Signed Copies of Bank Statement of the NGO for the last 3 years certified by the Bank Manager.
8. IT Return of the NGO for the last 3 years.
9. Registration at NGO Darpan under NITI AYOG, Govt. of India.
10. PAN Card of the NGO.
11. TAN Registration Certificate.
12. The NGO should have minimum 3 years experience in the field of Domestic Violence, Prevention, Rescue, Rehabilitation of Trafficking and Welfare of Women.

Interested CSO/NGO shall submit their EOI in their letter head along with the above mentioned documents to the undersigned within 10-09-2019 during office hour from the date of issue of the EOI.
