ORDER

In continuation of the earlier order issued vide No. DDMA/Goalpara/37/2020/198-200 dated 12th May, 2021 and in exercise of the power conferred upon me section 30(2)(iv),(2) (v) & (2) (xxix) of the Disaster Management Act, 2005, I Smt. Varnali Deka, IAS, Deputy Commissioner cum Chairperson, District Disaster Management Authority (DDMA), Goalpara keeping in view of the emergent nature of the situation, hereby issues the following directives which will be applicable in respect of urban areas and adjacent areas within 5 km radius from the periphery of municipal boards / revenue towns and shall come into force with effect from **5 AM of May 16, 2021** until further orders.

1. All shops and commercial establishments shall shut down at 11 AM on all days.
2. All vehicles other than government vehicles those exempted vide order No. DDMA/Goalpara/37/2020/204-206 dated 13/05/2021 will be allowed to ply in accordance with an odd-even formula decided by the DDMA, Goalpara between 5 AM to 12 noon. However, this resection shall not apply to personal vehicle used for medical emergencies.
3. There shall be total ban on movement of individuals from 12 noon to 5 AM daily, except for exemptions specified in Order No. DDMA/Goalpara/37/2020/204-206 dated 13/05/2021.
4. Other restrictions as notified vide order No. DDMA/Goalpara/37/2020/198-200 dated 12/05/2021 and clarification issued vide order No. DDMA/Goalpara/37/2020/204-206 dated 13/05/2021 shall continue except the modification of timing as above.
5. The rural areas not covered by order No. DDMA/Goalpara/37/2020/198-200 Dated:12/05/2021 shall continue be governed by restrictions stipulated vide order No. DDMA/Goalpara/37/2020/180-183 Dated:04/05/2021.


The above order is issued to further strengthen the containment of spread of COVID-19.
