(1) The intending candidates for engagement for the post of RCC Trained Personnel having the following requisite qualifications may appear before the Selection Committee with all required testimonials in original.

(A) Qualification Criteria: -

Minimum HSSLC passed with 6 (Six) months Diploma in Computer Application with proficiency in MS-Office and Assamese Typing.
(Candidates with experience in Land Records Computerization/Dharitree will be given preference).

(B) Age: - The candidate should have completed 21 years as on 1st January'2021 and shall not be more than 40 years on that day.

(C) Required Testimonials (in original):-

- (1) Birth Certificate/ HSLC Admit card or Certificate as proof of date of birth.
- (2) Educational certificates.
- (3) Experience certificate. (If any)
- (4) Diploma in Computer application.


2) The intending candidates for engagement of RCCC Trained personnel may appear before the Selection Committee with all above mentioned testimonials along with the RCCC training Completion Certificate in original. The candidates who have undergone RCCC training in Govt. ASSTC, Guwahati selected from Goalpara district will be given preference.
