

Role and Function

1. The Committee will play role in the successful implementation of the Scheme in the selected villages having more than 50% SC population.
2. The Committee will ensure that PMAGY fund serve the purpose of gap filling, while saturation in infrastructure & improvement of socio economic indicators is achieved by way of convergence with various Central & State Schemes.
3. The Committee will be responsible for implementation and monitoring of schemes under gap filling fund.
4. The Committee will be responsible for conducting Need Assessment, collecting the baseline data preparation of the VDP as well as implementation and monitoring of the Scheme in the village.
