ORDER

Whereas a large number of COVID-19 positive cases have been detected in the district which have become a threat to public health and life.

Whereas, there is every need for containment of spread of COVID-19 in the district in order to break in the chain and prevent the apprehended danger to human life and health by way of restricting gathering in public places as communicated vide order of the Chief Secretary & Chairman Executive Committee, ASDMA vide order No. ASDMA.28/2021/63 dated 05-05-2021.

And whereas the weekly and bi-weekly Haats/Markets are identified to be such places of public gathering where from the spread of the disease cannot be ruled out.

Therefore, I Smti.Varnali Deka, IAS, Deputy Commissioner cum Chairman, District Disaster Management Authority, Goalpara in exercise of the powers conferred upon me under the Section 34 (c) (h), (j), (m) of the Disaster Management Act- 2005 &144 Cr.PC do here by order the closure of all weekly and bi-weekly markets under the Goalpara District.

Any person violating this order will be liable to be proceeded against as per provision of Section 51 to 60 of the Disaster Management Act, 2005, decide legal action under Sec. 188 of the IPC and other legal provisions as applicable.

This order comes in to force with immediate effect until further order.
