4. If found that the successful bidder is incompetent to provide the products/service requested, in such situation, the proposal may be reviewed for award of the contract to the next qualifying bidder or go for a fresh bid depending on the circumstances.
5. The successful bidder will be liable for installation of water purifiers in the respective locations and will provide annual maintenance for 03 (three) years.
