SHORT NOTICE INVITING QUOTATION

Sealed Quotation affixing non refundable Court Fee Stamp of Rs.8.25 (Rupees Eight & Paise Twenty Five) only for performing **STREET PLAY (BATOR NAT)** as under are invited from the intending N.G.O.s and will be received up to 2 PM of **10th JULY /2015**. This will be opened on the same date at 2:30 PM in presence of the parties or their authorized representatives. The rates should be quoted exclusive of all taxes.

Condition :

1. Rate should be quoted per Street Play including Mike set & LMV with necessary fuel.
2. Minimum 3 (three) nos. of street play should be performed in a day.
3. Street play should be performed in any place within the District Goalpara .
4. At least 5 (five) nos of still colour Photograph should be submitted for each Street Play.
5. Video Camera alongwith operator will be provided by this Office, if required.
6. The Tender shall be accompanied with up-to-date certificate of Income Tax Return (Computerized Income Tax return acknowledgement) and VAT Clearance Certificate in Form -63.
5. The Tender shall be accompanied with PAN/TIN/GRN/NGO Registration Certificate/Bank Accounts with address . Photocopies of all the documents should be furnished.
6. The quotationer shall have to be deposit a sum of **Rs. 5,000.00** (Rupees five thousand) only within 15 (Fifteen) days from the date of accepted quotation in the form of Bank Draft/DCR from any Nationalised Bank pledge in favour of the District Election Officer, Goalpara and payable at Goalpara as **Security Deposit**, which shall be refundable on satisfactorily completion of the assigned job and after the contract period is over. The Deputy Commissioner, Goalpara reserves the right to forfeit the Security Deposit in case of any rejection and no compensation will be paid for such rejection.
7. This Office gives no assurance to the L-1 bidder to award the work at his quoted rate. If the undersigned finds that the L-1 rate is on the higher side, the undersigned may negotiate the price with L-1 bidder at the rate deemed appropriate .The undersigned reserves the right to accept or reject any quotation without assigning any reason thereof .
